### MID-AMERICA FIDDLIN' CHAMPIONSHIP JUNE 8 & 9 at BETHEL, MO

The Bethel German Communal Colony at Bethel, Missouri, is sponsoring the first annual Mid-America Old-Time Fiddlin' Championship and Convention to be held on June 8 & 9, 1985. MSOTFA is running the contest and we are inviting fiddlers from Missouri and all surrounding states to participate.

The convention opens officially at Noon on Saturday, June 8, but we are already anticpating many early arrivals on Friday night. Camping with hookups will be available as well as several reasonably priced motels within easy distance of the contest.

The contest features three divisions: junior, senior, and open. Eliminations will be held on Saturday evening beginning at 5:00 PM. Finals will be held at Noon on Sunday. Anyone called back to play on Sunday is assured of finishing in the money. The entire event should be over no later than 5:00 PM Sunday.

Qualified judges have been selected representing three Midwestern states.

In addition to prizes and trophies in three divisions, there will be three prizes for best accompanists, a cash prize to the fiddler or accompanist travelling the greatest distance, and trophies for the oldest and youngest fiddler. As an added attraction, there will be a special one-round Novelty/Trick tune contest on Saturday Night in which anything goes.

There will be no entry fees or admission charges to fiddlers or accompanists who register to compete the day of the event. Also, each fiddler and accompanist will be permitted one free admission for a member of their immediate family for each day they are registered to compete.

### MEMBERSHIP BY-LAWS CHANGED

MSOTFA has in the past offered membership free of charge for the first year of enrollment to allow potential members to decide whether they could benefit from participation. Response has been excellent and over 150 persons have enrolled. However, after June 30, 1985 membership dues will be payable immediately upon enrollment.

Also, after June 30 membership dues will increase to \$5.00 per year. If you pay your 1985-86 before June 30 the old rate of three dollars will still apply. We do not anticipate a need to increase dues for many years to come.

### NEW OFFICER SELECTED

John Stewart, accompanist of Columbia, Missouri, has been selected to fill the position as 1st Vice President which was left vacant when Chris German moved out of the state.

### TINA REUNION A BIG SUCCESS

The 2nd annual Missouri Valley Old-Time Fiddlers Reunion was held on May 3 & 4 at Tina in Carroll County, Missouri. The event was sponsored by MSOTFA in cooperation with the Tina Fiddlers.

An estimated 300 people took part in the weekend activities. Over thirty fiddlers and accompanists were on hand to provide music for the dancers. There were plenty of impromptu "jams" all around town.

### CONTEST SCRAPBOOK.

The Boonville fiddle contest, first held in 1964, is one of the longest-running contests in the state. Sponsored by the Independent Order of Odd Fellows, Far West #4, the contest was initiated by fiddlin' Cecil Windsor as a fund-raising event for the lodge. The contest is held every year in March in the Laura Speed Elliot Junior High Auditorium in Boonville. The event is not held in conjunction with any other attractions and is for that reason somewhat unique.

The contest usually commences at around 7:00 PM. The fiddling performances are often separated by renditiions of country songs provided by local talent. There is a door prize drawing for a variety of donated items. A food counter is kept open throughout the contest by the Rebeccas, the IOOF women's group. Ham sandwiches, sweets, and coffee are served. There is ample warm-up space in the hallways surrounding the auditorium.

Boonville has enjoyed fine participation by fiddlers, never

having had fewer than 15 and many years approaching 30 contestants. This is due in part to the well organized manner in which the contest is run and the fact that Boonville represents the beginning of the contest season after the musical lull of a Missouri winter. Harvey Harris and Clinton McCleary are the co-chairmen for the contest.
